Overview

Organised by HSBC Commercial Banking and Hong Kong Economic Times (“HKET”), the **HSBC x HKET Innovative Business Award (the “Award”)** was first launched in 2018 to recognise Hong Kong businesses which have broadened their horizons to achieve ground-breaking success through innovation and technology. Entering its second year, the Award aims to inspire and encourage local SMEs and startups to embrace creativity and technology in building new and sustainable business models, elevating their competitiveness in the market, and driving prosperous long-term growth.

Objectives

1. Promote a culture of entrepreneurship and continuous innovation across businesses.
2. Recognise the outstanding achievements of Hong Kong SMEs and startups in embracing technology; adopting innovative business models, products and/or services; or achieving technological breakthroughs.
3. Encourage the use of technology and innovation for new business development.

Eligibility

Innovative SME

1. Companies registered in Hong Kong* before 19 July 2014, which have been established for more than five years with solid business operations.
2. All types of businesses are eligible including technology companies; companies from emerging industries; companies with evidence of successful business transformation via technology and innovation; and companies that have invented new products, services or business models.
3. Companies registered with the HKSAR Government that hold all valid permits and licenses required or necessary for their businesses and operations.
4. Companies that have attained a minimum turnover of HK\$5 million in the latest financial year.
5. Listed companies and their subsidiary companies are not eligible to join.

Innovative Startup

1. Companies registered in Hong Kong* on or after 19 July 2014, which have been established for five years or less with solid business operations.
2. All types of businesses are eligible including technology companies; companies from emerging industries; companies with evidence of successful business transformation via technology and innovation; and companies that have invented new products, services or business models.
3. Companies registered with the HKSAR Government that hold all valid permits and licenses required or necessary for their businesses and operations.
4. The representative must be a company founder that currently holds an active managerial and/or operational role in the company.

*Determined by the date of incorporation on Certificate of Incorporation (applicable to incorporated limited company only) or Certified Extract of Information on the Business Register (applicable to non-incorporated limited companies only).

Application Method

1. Companies must submit an online application via the Award website successfully **on or before 6pm, 31 July 2019**.
2. The following items are required in the submission:
 - Duplicate copies of Hong Kong company registration, and all valid permits and licenses required or necessary for their businesses and activities, e.g. Business Registration Certificate
 - Duplicate copies of the Certificate of Incorporation and Business Registration Certificate (applicable to limited company only), duplicate copies of the Certificate Extract of Information on the Business Register, or any other documents issued by the HKSAR Government as proof of the applicant company's date of incorporation
 - Founder information for "Innovative Startup"
 - Details about the innovative product, service, business model or process
 - Details about the innovative practice, proprietary technology or application of the kind of technology that boosts efficiency, reduces cost, or significantly contributes to income
 - Duplicate copies of the latest tax return(s) and tax bills, and audited accounts (if statutory audit is required) or financial statements of the previous year

Selection Process

31 July 2019
On or before 6pm

1. Companies must submit applications by the mentioned deadline (see "Application Method"); if the companies have been requested to provide any supplementary information, they must provide the supplementary information by the designated deadline.

Site Visit

2. The technical partner may visit the shortlisted companies for a better understanding of the operations if necessary.

2 October 2019

3. All first-round shortlisted companies must attend the first interview on **2 October 2019**.

18 October 2019

4. All finalists must attend the final interview on **18 October 2019**.

15 November 2019

5. All winners will be notified separately and will be invited to join the Award presentation ceremony on **15 November 2019**.
